#### Summary of the partner`s work

Please describe the project progress which was achieved by the partner in the current period. In particular, please highlight if specific deliverables and/or outputs were reached. If applicable, also explain problems/deviations which were encountered during the current period.

In the current reporting period, within the thematic work packages, the Vysocina Region contributed to preparatory works to elaboration of the RUMOBIL strategy outline (WP T1) and has finished the preparation of the pilot action, which was followed by launch of new public transport connections to better link rural areas to national and EU transport network (WP T2).

The thematic activities have been accompanied by adequate communication and promotion measures in line with the project communication strategy (WP C), in particular updated information for relevant target groups and stakeholders, distributed by various communication channels, and the transnational competition entitled "We live for public transport".

Throughout the whole reporting period, a regular communication and exchange with the project Lead partner and WP coordinators had been going on. In March 2017, the 2nd meeting of the Steering Group took place where previous achievements were summed up and tasks for the upcoming period defined.

As for problems encountered, PP3 - the WP C leader (Pro rail Alliance) has withdrawn from the project consortium due to financial difficulties not allowing him to continue working in RUMOBIL. A soultion of this situation has been proposed by the Lead partner: the WP C leadership will be assumed by PP4 and the tasks of the leaving partner will be redistributed among the remaining project partners. This proposal will be submitted for official approval at the next meeting of the project Steering Group, that will be held at the beginning of the next reporting period (8 - 9 June 2017).

On 1 - 2 March 2017, the Vysocina Region project team participated in a partner workshop and the 2nd meeting of the Steering Group that have been held in Ozalj and Zagreb, Croatia. During this event, the previous achievements within the different work packages have been summed up and tasks and deadlines for the upcoming period defined. Furthermore, throughout the whole reporting period, a regular communication and exchange with the project Lead partner and WP coordinators had been going on, as well as with the relevant stakeholders - in particular with the Vysocina Region decision makers and with the bus transport operators who will provide public transport services within the pilot action. As a part of the project implementation, other stakeholders, such as general public or elementary and secondary schools have been addressed and involved, for details see descriptions in the thematic and communication work packages.

Please describe the activities and the progress made within this work package in the current reporting period. For thematic and communication work packages, please explain how target groups (and other stakeholders) were involved in the activities and development of the project outputs.

Initial works to elaborate the RUMOBIL strategy have begun. The concrete steps to be taken have been presented by WP T1 coordinator at a partner workshop in Zagreb/Ozalh on 1-2 March 2017 (see deliverable D.T1.2.1). Consequently, in cooperation of all project partners, the outline of the strategy and proposal of its structure and contents has been prepared, to be further developed within the next reporting periods. The Vysocina Region provided the input information required by WP T1 coordination, in terms of the problems tackled in the region and proposed types of solutions to be implemented. The strategy will be based on knowledge and learnings, that have been gathered during the study trips and good practices identification in the previous reporting period and summarised in the work paper "Learning from good practices" (deliverable D.T1.1.3). Further inputs to the strategy will be taken from the work papers "Macro-economic effects of public transport for rural regions" (D.T1.3.1), "Opportunities and boundaries of transport network telematics" (D.T1.3.2) and "New demand patterns for public transport due to demographic change" (D.T1.3.3), that will be elaborated till November 2017, as well as from learnings from pilot actions (WP T2).

Preparatory works for the pilot activity (A.T2.1) - establishing a new public transport connection between the regional centre and a peripheral area of the region - have been finished, in particular specification of the pilot locality, list of public transport connections for the pilot and estimated costs of their operation (for details see the deliverable D.T2.1.2). Based on these technical specifications, the new public bus transport connections have been put into operation in March/April 2017. They will be ensured by 4 transport operators - ICOM transport a.s., ARRIVA Východní Čechy a.s., TRADO-BUS s.r.o., ZDAR a.s. Amendments to the existing contracts with these operators were concluded during March/April 2017. The launch of the pilot activity has been accompanied by an information and publicity campaign for general public (D.T2.5.2): information at the Vysocina Region website

(http://www.kr-vysocina.cz/rumobil-mobilita-v-evropskych-regionech-venkovskeho-charakteru-dotcenych-demografickymi-zmenami/d-4076707/p1=1013), information in press (Vysocina Region newspaper, Journal for mayors of municipalities), information leaflets for passengers, project logo on the buses. In coordination by the WP T2 leader, a set of monitoring indicators (D.T2.1.3) has been defined. The aim is to assess the success of the pilot actions and compare the situation before and after the pilot. The indicators are divided into several groups - geographical, socio-demographic, operational, economic, qualitative. The baseline values of these indicators will be summarised in the pilot launch report (D.T2.2.10), which will be elaborated by August 2017.

The thematic activities have been accompanied by adequate communication and promotion measures in line with the project communication strategy (WP C), in particular updated information for relevant target groups and stakeholders, distributed by various communication channels: - Vysocina Region website (http://www.kr-vysocina.cz/rumobil-mobilita-v-evropskych-regionech-venkovskeho-charakteru-dotcenych-demografickymi-zmenami/d-4076707/p1=1013) - information in press (Vysocina Region newspaper, Journal for mayors of municipalities) - information leaflets regarding the pilot action In January 2017, the Vysocina Region officially launched the transnational competition (D.C.2.1) to collect new ideas for public transport and to raise awareness about the RUMOBIL project. The competition, entitled "We live for public transport: the most urgent problem of public transport in Vysocina from my point of view", was intended for students of all elementary and selected secondary schools in the Vysocina Region. The students were addressed with the task to draw or paint what they feel as the most pressing problem of public transport in the city or village they live in, how the problem might be tackled and how an ideal means of public transport should look like. The ideas gathered throughout the competition will form a valuable input for future shaping of public transport services in the Vysocina Region. Within the competition deadline, that was set to the end of March, 203 art works from 19 schools were received and evaluated in 3 age categories (6 – 7 years, 8 – 10 years, 11 – 15 years) in line with the evaluation criteria fixed by the competition rules. ## If applicable, please describe and justify any problems and deviations including delays from the work plan as presented in the application form and the solutions found.

The transnational competition, originally due till February 2017, was finished at the beginning of May 2017. Later conclusion of this activity was related to the intention to give the schools and students enough time to prepare their contributions in high quality, to carefully evaluate the competition art works, that have been received in higher quantity than expected, and to prepare the official announcement of results. Moreover, in line with the Vysocina Region internal regulations, the results of the competition had to be officially approved by the competent regional decision-making body - Vysocina Regional Council prior to their announcement.
